Alternatives to Open Burning of Raisin Trays

Phase-out Schedule for Open Burning of Raisin Trays

On June 17, 2021, the San Joaquin Valley Air Pollution Control District's (District's) Governing Board voted to approve the District's Supplemental Report and Recommendation on Agricultural Burning. The supplemental report was developed by District staff in close coordination with the California Air Resources Board (CARB), the interested public, and agricultural stakeholders, to address state mandates (SB 705 Florez, 2003) by developing an updated phase-out schedule to achieve the near-complete phase out of agricultural burning in the San Joaquin Valley by January 1, 2025. CARB provided concurrence with the supplemental report on June 18, 2021. As one component of the adopted phase-out requirements, all raisin tray open burning will be prohibited effective January 1, 2024.

As the District strives to meet attainment with strict Federal air quality standards, allocation for agricultural burning has become increasingly limited. The District strongly encourages growers with phase-out deadlines to explore alternative means of disposal prior to requesting a burn permit. **Please note that starting January 1, 2024**, raisin paper trays will no longer be a valid crop code on existing agricultural burn permits and no burn permits will be issued for raisin paper trays.

Grant Funding Available for Alternatives to Burning Raisin Trays

On October 19, 2023, the District's Governing Board approved the Incentive Program for Non-Combustion Alternatives to Open Burning of Raisin Trays to assist growers with the cost to utilize alternative disposal methods. The program offers incentive funding for non-burning alternatives such as recycling or waste disposal to all growers for the 2023 harvest season. Accompanying this bulletin is a list of waste haulers that indicated they offer roll-off dumpster services, and a list of disposal sites that indicated they accept raisin trays. Eligibility for incentive funding is based on the criteria below:

Total Farmed Acreage	Incentive	Availability	Alternative Disposal Methods
≤100 acres	Up to \$35/acre	2023-Harvest	Roll-Off Dumpster Service, Self-Haul
>100 acres	Up to \$35/acre \$2,000 cap	Season
