- 10. <u>REPORT ON DISTRICT CITIZENS ADVISORY COMMITTEE ACTIVITIES</u> Mr. Sheikh referred Board Members to the written report in the absence of a CAC representative.
- 11. <u>ADOPT RECEIVE THE GOVERNMENT FINANCE OFFICERS' ASSOCIATION</u> <u>CERTIFICATE OF ACHIEVEMENT FOR EXCELLENCE IN FINANCIAL</u> <u>REPORTING</u> – Ryan Buchanan, Director of Administrative Services, and announced that the District has been awarded the Government Finance Officers' Association of the United States (GFOA) Certificate of Achievement for Excellence in Financial Reporting for the District's Annual Comprehensive Financial Report (ACFR) for the fiscal year ending June 30, 2023 for the tenth year straight. 12. ACCEPT AND APPROPRIATE \$59,400,000 IN STATE FUNDING AGRICULTURAL MEASURES FOR EMISSION REDUCTION (FARMER) PROGRAM FUNDING FOR THE REPLACEMENT OF AGRICULTURAL EQUIPMENT – Todd DeYoung, Director of Grants and Incentives, presented the proposal seeking Board approval to accept and appropriate \$59.4 million in state funding for the replacement of agricultural equipment.

Supervisor Mendes congratulated the District on efforts to assist the many applicants who are utilizing these grants.

Supervisor Macaulay thanked the District for all of the work on programs like these, and asked about the average time frame for the application process. Mr. DeYoung responded that it can currently take up to a year to complete the process due to the significant level of participation in the program.

Councilmember Bessinger shared his appreciation of the advocacy efforts that were done in order to get the FARMER program funds incorporated into the state budget and to bring these funds to the Valley.

Motion unanimously carried to (1) accept and appropriate \$59,400,000 in state FARMER Program funds from the California Air Resources Board to fund the replacement of agricultural equipment in the San Joaquin Valley and authorize the District to administer this funding in accordance with current and future FARMER Program guidelines; (2) approve the attached Budget Resolution to amend the 2023-24 District Budget to appropriate \$59,400,000 in additional revenue; and (3) authorize the Executive Director/APCO to make administrative changes to the program as necessary to ensure successful program implementation.

13. <u>UPDATE ON AB 617 IMPLEMENTATION AND APPROVE NEW INCENTIVE</u> <u>PROGRAMS BENEFITTING VALLEY COMMUNITIES</u> – Jessica Olsen, Director of Community Strategies and Resources, shared AB 617 updates and new opportunities for the use of Community Air Protection funds.

Supervisor Macaulay asked for clarification on the AB 617 community selection process and if there is any indication of which new communities may be selected in the future. Mr. Sheikh explained that the communities are chosen by CARB under statute. Additionally, he shared that there has not been any increase in the resources for the program and CARB is beginning to transition the model of the program from a limited number of selected communities to using various funding streams to work more broadly with low income and disadvantaged communities across the state.

Supervisor Macaulay discussed the impact of the school bus replacement program on mountain communities since they usually procure used buses from larger, urban school districts and hopes there can be a way to prevent higherquality buses from being destroyed and potentially making them available through a trade up program for use in rural mountain communities.

Dr. Sherriffs inquired about the current queue of projects, the preference to get the oldest buses out of use first, and if bio methane is being considered as near zero fuel. Mr. DeYoung responded that there are a few dozen applications in the queue with one of the provisions in place to focus on replacing the oldest buses first. Mr. DeYoung also explained that the program design incorporates natural gas fueling infrastructure for low NOx natural gas, which the state recognizes as near-zero emission technology.

Supervisor Rickman asked about the prohibition of using public funds for sectarian or denominational schools. Annette Ballatore, District Counsel, responded that under the California Constitution, school funding specifically for school buses, transporting students to religious schools for religious training, does not qualify.

Councilmember Bessinger inquired about the program's eligibility, and how would it affect smaller, low-income schools within districts that are primarily affluent. Mr. Sheikh explained that there is a state-established tool named CalEnviroScreen that has established definitions in response to AB 1550, SB 535, and other mandates.

Mayor Preciado said that electric buses would not likely be able to be utilized in areas like in his community of Avenal because of the distances required to be traveled and the hills in the area. Mayor Preciado stated there is a need to bring these programs to communities like Avenal that are affected by mobile traffic from highways and freeways, but are not currently a selected AB 617 community. Mr. Sheikh responded that through Board and community engagement efforts, these programs will be grown to include and benefit low-income and disadvantaged communities throughout the Valley.

Motion unanimously carried to (1) receive progress report on implementation of Community Emissions Reduction Programs (CERPs) for South Central Fresno, Shafter, Stockton, and Arvin/Lamont AB 617 communities; (2) accept and appropriate \$64,316,475 in new state Community Air Protection funding from the California Air Resources Board to fund voluntary emission and exposure reduction projects benefitting AB 617 and low-income/disadvantaged communities Valley-wide; and (3) approve the attached Budget Resolution to amend the 2023-24 District Budget to appropriate \$64,316,474 in new state funding, including \$60,296,695.32 in project funds and up to \$4,019,779.68 in administrative funds.

14. <u>ADOPT PROPOSED AMENDMENTS TO DISTRICT RULE 4402 (CRUDE OIL</u> <u>PRODUCTION SUMPS)</u> – Sheraz Gill, Deputy APCO, presented this item and recommended the Board adopt the proposed amendments to Rule 4402 (Crude Oil Production Sumps) to satisfy state Best Available Retrofit Control Technology requirements and federal ozone state implementation plan commitments.

Supervisor Mendes asked how many open pits are in the area, since he sees mostly tanks. Mr. Gill responded that most open pits have been replaced by storage tanks and there is a very small number of open pits.

15. <u>ADOPT PROPOSED DISTRICT RULES 3172 (FEDERALLY MANDATED</u> <u>OZONE NONATTAINMENT FEE – 2008 8-HOUR STANDARD) AND 3173</u> (FEDERALLY MANDATED OZONE NONATTAINMENT FEE – 2015 8-HOUR <u>STANDARD</u>) – Morgan Lambert, Deputy APCO, presented this item and recommended the Board adopt proposed Rules 3172 and 3173 to satisfy federal clean air act requirements in the event the Valley does not reach attainment of the 2008 or 2015 8-hour ozone standard.

Councilmember Bessinger asked what examples of major stationary sources. Mr. Lambert responded that major NOx stationary sources would generally include large combustion units like power plants and major VOC stationary sources could include oil and gas operations, landfills, or composting operations.

16. <u>VERBAL REPORT ON CALIFORNIA AIR RESOURCES BOARD (CARB)</u> <u>ACTIVITIES</u> – Samir Sheikh shared the CARB update in Dr. Pacheco-Werner's absence and referred Board Members to the written report. Mr. Sheikh highlighted that CARB approved the funding plan for Clean Transportation Incentives of \$624 million that includes a \$140 million funding plan called Community Facing programs that will have the Clean Cars for All as a large part of that program. Mr. Sheikh thanked Dr. Pacheco-Werner for her advocacy for the San Joaquin Valley.

<u>EXECUTIVE DIRECTOR/APCO COMMENTS</u> – Mr. Sheikh thanked Supervisor Chiesa and Councilmember Escutia-Braaton, along with the entire Board for the work and support with the Clean Air Ag press event in November. Mr. Sheikh also expressed appreciation for all of the great discussions and participation in the Study Session. Additionally, Mr. Sheikh shared the recent series of approval actions by EPA related to PM2.5 contingency which have stayed potential transportation funding sanctions on the Valley. Lastly, Mr. Sheikh shared some of the efforts by the District staff to serve the communities with charitable work that included: food drives, a holiday giving tree event to sponsor children, and a blanket drive.

- 18. <u>GOVERNING BOARD MEMBER COMMENTS</u> Supervisor Robinson congratulated the calendar art winners from the Lee Richmond School that is located near his home. Councilmember Lewis thanked the staff for its effortless and smooth operations of the District and congratulated the STAR employee of the year recipients. Supervisor Rickman congratulated Chair Chiesa and Vice Chair Lewis for their continued service as Chair and Vice Chair.
