The public hearing may also be attended through video teleconferencing at 2700 "M" Street, Suite 275, Bakersfield, California and at 4800 Enterprise Way, Modesto, California. At said hearing, the Governing Board of the San Joaquin Valley Unified Air Pollution Control District (SJVUAPCD or District) will consider adopting a plan affecting the counties of Fresno, Kern, Kings, Madera, Merced, San Joaquin, Stanislaus, and Tulare. The following action will be considered at said hearing:

**Adopt the Proposed *2007 Ozone Plan***

NOTICE IS FURTHER GIVEN that the adopted *2007 Ozone Plan* will be submitted through the California Air Resources Board to the United States Environmental Protection Agency for incorporation as part of the California State Implementation Plan (SIP). Said proposed action would constitute a SIP revision.
