### I. PROPOSAL

West Kern Water District (facility S-349) was first issued a Title V permit on January 13, 2000, which was last renewed on February 20, 2018. As required by District Rule 2520, the applicant is requesting a permit renewal. The existing Title V permit shall be reviewed and modified to reflect all applicable District and federal rules updated, removed, or added since the issuance of the last renewal of the Title V permit on February 20, 2018 to present.

The purpose of this evaluation is to provide the legal and factual basis for all updated applicable requirements and to determine if the facility will comply with these updated requirements. It also specifically identifies all additions, deletions, and/or changes made to permit conditions or equipment descriptions.

### II. FACILITY LOCATION

West Kern Water District (facility S-349), Station B, is located approximately 1 mile southeast of the intersection of Highway 119 and Airport Road in Taft, CA.

### III. EQUIPMENT LISTING

A detailed facility printout listing all permitted equipment at the facility is included as Attachment C.

The applicant does not propose to use any model general permit templates.

### VII. REQUIREMENTS NOT FEDERALLY ENFORCEABLE

For each Title V source, the District issues a single permit that contains the Federally Enforceable requirements, as well as the District-only requirements. The District-only requirements are not a part of the Title V Operating Permits. The terms and conditions that are part of the facility's Title V permit are designated as "Federally Enforceable Through Title V Permit".

For this facility, the following are not federally enforceable and will not be discussed in further detail:

### A. Rules Added/Updated

There are no new rules that are not federally enforceable being added at this time.

### **B. Rules Not Updated**

### VIII. PERMIT REQUIREMENTS

The purpose of this evaluation is to review changes to federally enforceable requirements; therefore, this compliance section will only address rules that have been amended or added since the issuance of the most recent renewal of this facility's Title V permit, which occurred on February 20, 2018.

### A. District Rule 2201 - New and Modified Stationary Source Review Rule

District Rule 2201 has been amended since this facility's last Title V permit was issued. However, the requirements of this rule are only triggered at the time the source undergoes a modification. All applicable requirements from any NSR permit actions have already been incorporated into the current Title V permit. The updated requirements of this rule are therefore not applicable at this time.

However, administrative changes were made to the conditions listed below. The conditions reference "NSR Rule", but that reference has been replaced with "District Rule 2201" for the following conditions:

### B. District Rule 2520 - Federally Mandated Operating Permits

There are no federally applicable Greenhouse Gas (GHG) requirements for this source. It should be noted that the Mandatory Greenhouse Gas Reporting rule (40 CFR Part 98) is not included in the definition of an applicable requirement within Title V (per 40 CFR 71.2). Therefore, there will be no further discussion of GHG in this evaluation.

### C. District Rule 4601 – Architectural Coatings

This rule limits the emissions of VOCs from architectural coatings, and it specifies architectural coatings storage, cleanup, and labeling requirements.

This rule was amended on April 16, 2020. The amendments to the rule include the following:

- Numerous definitions were added, deleted or modified in order to make the amended rule harmonize with definitions and rule requirements presented in the California Air Resources Board (ARB) Suggested Control Measures (SCM).
- The amended rule implements the recommended VOC limits per the ARB SCM. The following changes were as follows: 15 coating categories were eliminated, 10 were added, 19 coatings categories remained unchanged, and the VOC content limits for 19 categories were lowered.
- The phrase "blends or repackages" was added to rule language to extend the applicability of rule language to facilities involved in those activities.
- A reporting requirement was added for any architectural coating that is sold in a container with a volume of one liter or less. The exemption for architectural coatings was further defined by adding "coatings that are supplied and offered

for sale" to current language, in order to make the rule consistent with the ARB SCM.

- Labeling requirements were updated to add new labeling standards consistent with new coatings categories per the SCM.
- A new section was added to include reporting requirements per the SCM. The SCM contains a new requirement to submit sales data. Collection of this data is authorized in the California Health and Safety Code which requires submission of data to estimate emissions.
- New sections were added to coincide with new coating categories pursuant to the ARB SCM.
- The compliance schedule was updated to account for the new amendments to rule language by adding the phrase "the dates specified within the text of the rule."

The only reference to this rule is in the facility-wide permit (S-1327-0), specifically by conditions #23 through #25 and #40. The following existing conditions have been revised as shown in strikethrough/underline to reflect the changes to rule 4601 as follows:

- 23. No person shall manufacture, blend, repackage, supply, sell, solicit or apply any architectural coating with a VOC content in excess of the corresponding limit specified in Table of Standards 1 effective until 12/30/10 or Table of Standards 2 effective on and after 1/1/11 Table 1 or Table 2 of District Rule 4601 (12/17/09 4/16/20) for use or sale within the District. [District Rule 4601]
- 24. All VOC-containing materials subject to Rule 4601 (12/17/09 4/16/20) shall be stored in closed containers when not in use. [District Rule 4601]
- 25. The permittee shall comply with all the Labeling and Test Methods requirements outlined in Rule 4601 sections 6.1 and 6.3 (12/17/09 4/16/20). [District Rule 4601]
- 40. Compliance with permit conditions in the Title V permit shall be deemed in compliance with the following applicable requirements: SJVUAPCD Rules 1100, sections 6.1 and 7.0 (12/17/92); 2010, sections 3.0 and 4.0 (12/17/92); 2031 (12/17/92); 2040 (12/17/92); 2070, section 7.0 (12/17/92); 2080 (12/17/92); 4101 (2/17/05); 4601 (12/17/09 4/16/20); 8021 (8/19/2004); 8031 (8/19/2004); 8041 (8/19/2004); 8051 (8/19/2004); 8061 (8/19/2004); and 8071 (9/16/2004). A permit shield is granted from these requirements. [District Rule 2520]

Therefore, continued compliance with this rule is expected.

### D. District Rule 4702 – <u>Internal Combustion Engines</u>

The purpose of this rule is to limit NOx, CO, VOC, PM, and SOx emissions from internal combustion (IC) engines. This rule applies to any IC engine rated at 25 brake horsepower or greater. This facility has engines under permits S-349-1, -2, -3, -5, -6, and -7 that are subject to this rule.

District Rule 4702 was amended on August 19, 2021. The amended rule lowered NOx and VOC emissions from several categories of engines, established PM requirements for all categories of IC engines affected by the Rule, and it established SOx control requirements for agricultural engines.

S-349-6 is an emergency standby IC engine. Pursuant to Section 4.2, the only requirements that apply to emergency standby engines are the requirements of Section 5.10 (monitoring requirements) and 6.2.3 (annual operating records requirements), which were the same requirements of the previous version of the rule. There are no additional requirements that have been imposed on emergency standby engines. Therefore, continued compliance with the rule is expected for S-349-6.

The remaining five engines at this facility (S-349-1, -2, -3, -5, and -7) are rich-burn, natural gas-fired IC engines that are non-emergency and are part of a non-agricultural operations (Non-AO). These engines are currently subject to and in compliance with the emission limits in Table 2 (specifically Category 1.d.) as indicted in the table below that lists the current permit limits.

As is shown above, Table 3 has introduced lower VOC emission limits to the category of engines at this facility, lowering the VOC emissions from 250 to 90 ppmv. However, the current permit limits for engines S-349-1 through -3 are at 125 ppmv-VOC and the limit for S-349-7 is at 250 ppmv-VOC, greater than the applicable 90 ppmv-VOC limit of Table 3. Therefore, the VOC emissions limits for those four engines will need to be lowered by the full compliance date.

Normally, changing the emission limits on a permit would be done through an Authority to Construct application. However, for this project, the lowering of the VOC emission limit on the four permits will be accomplished and documented with this Title V Renewal application because the change will not result in change in the method of operation and the changes are administrative. According to the permittee, none of the engines will need to be physically modified to comply with the lower VOC limit. A review of the facility's source test results from the past few years indicates that the engines have been testing at much lower VOC emission rates than 90 ppmv. Source test results of the engine from May 24, 2022, which are found as Attachment D, indicate that the engines tested VOC emissions ranged from 0.14 to 1.13 ppmv-VOC for the engines at this facility.

Note that revising an emission limits to lower values to comply with Regulation IV rule is not considered an NSR modification (as defined in Rule 2201 Section 3.25) provided the unit currently meets the revised emission limits and there is no change in the method of operation needed. As mentioned above, the engines will comply with the lower VOC limits without a change in the method of operation.

Pursuant to the applicant's request, the VOC limits for the five engines (S-349-1 through -3, and -7 will be lowered to the new rule limit of 90 ppmv. Permit conditions will be changed as follows:

For S-349-1, -2, and -3:

Emissions from IC engine shall not exceed any of the following: NOx (as NO2) - 11 ppmv @ 15% O2 or 0.153 g-NOx/hp-hr, VOC – 90 125 ppmv @ 15% O2 or 0.606 g-VOC/hp-hr, CO - 2000 ppmv @ 15% O2 or 16.98 g-CO/hp-hr, PM10 - 0.204 g/hp-hr, or SOx (as SO2) - 0.0145 g/hp-hr. [District Rules 2201 and 4702]

For S-349-7:

12. Emissions from this IC engine shall not exceed any of the following limits: 11 ppmvd NOx @ 15% O2 or 0.15 g/bhp-hr, averaged over at least 15 minutes; 1900 ppmvd CO @ 15% O2 or 16.132 g/bhp-hr, averaged over at least 15 minutes; 90 250 ppmvd VOC @ 15% O2 or 1.213 g/bhp-hr, averaged over at least 15 minutes; 0.075 g-PM10/hp-hr; 0.011 g-SOx/hp-hr. [District Rules 2201and 4702]

The other change to Rule 4702 to that may affect this facility is the establishment of PM requirements for all categories of IC engines affected by the Rule with the addition of requirements of Section 5.8 (Particulate Matter (PM) Emission Control Requirements). Section 5.8.1 requires that spark-ignited engines comply with the requirements of Section 5.7 (Sulfur Oxides (SOx) Emission Control Requirements) on and after the compliance schedule specified in Section 5.2.4 and 7.0.

The engines subject to this requirement (S-349-1, -2, -3, -5, and -7) all currently comply with the requirements of Section 5.7 (specifically Section 5.7.1 and 5.7.2)<sup>2</sup> with the following condition that is currently found on each of the five permits:

<sup>&</sup>lt;sup>2</sup> 5.7.1 Operate the engine exclusively on PUC-quality natural gas, commercial propane, butane, or liquefied petroleum gas, or a combination of such gases; or

<sup>5.7.2</sup> Limit gaseous fuel sulfur content to no more than five (5) grains of total sulfur per one hundred (100) standard cubic feet;

For S-349-1, -2, -3, -5, and -7:

 Unit shall be fired on PUC quality natural gas with a sulfur content of less than or equal to 0.017% by weight or on liquefied petroleum gas (LPG) with a sulfur content of less than or equal to 0.008% by weight. [Kern County Rule 407 and District Rules 2201, 4702 and 4801]

The remaining requirements of Rule 4702 have not been changed by the amended rule. Therefore, compliance with this rule is expected.

# E. 40 CFR 60 Subpart IIII - <u>Standards of Performance for Stationary</u> <u>Compression Ignition Internal Combustion Engines</u>

This subpart applies to compression-ignited engines. All engines at the facility are spark-ignited IC engines. Therefore, this subpart does not apply.

# F. 40 CFR 60 Subpart JJJJ - <u>Standards of Performance for Stationary Spark</u> <u>Ignition Internal Combustion Engines</u>

Pursuant to §60.4230, the provisions of this subpart apply to owners and operators of stationary, spark ignition (SI), internal combustion engines whose construction date began after June 12, 2006 or that were modified<sup>3</sup> or reconstructed<sup>4</sup> after that date.

All of this facility's SI IC engines commenced construction prior to June 12, 2006 and subsequently have not been modified or reconstructed. Therefore, this subpart does not apply.

# G. 40 CFR 63 Subpart ZZZZ - <u>National Emission Standards for Hazardous Air</u> Pollutants for Stationary Reciprocating Internal Combustion Engines

This subpart establishes national emission limitations and operating limitations for hazardous air pollutants (HAP) emitted from stationary reciprocating internal combustion engines (RICE) located at major and area sources of HAP emissions. This subpart also establishes requirements to demonstrate initial and continuous compliance with the emission limitations and operating limitations.

The facility has six spark-ignited IC engines (S-349-1, -2, -3, -5, -6, and -7) that are subject to Subpart ZZZZ.

Modification is defined in 40 CFR 60.14 as any physical change in the method of operation of an affected facility which increases the amount of any pollutant emitted by such source or which results in the emission of air pollutant not previously emitted.

<sup>&</sup>lt;sup>4</sup> Reconstruction is defined in 40 CFR 60.15 as a modification to an existing facility to such an extent that the capital cost of the new or refurbished components exceeds 50 percent of the fixed capital cost of a comparable entirely new unit.

The updates to Subpart ZZZZ since the last permit renewal of February 20, 2018 are summarized below:

- The November 19, 2020 amendment finalized changes to the General Provisions that apply to NESHAP. These amendments implemented the plain language reading of the "major source" and "area source" definitions of section 112 of the Clean Air Act and provided that a major source can be reclassified to area source status at any time upon reducing its potential to emit HAP to below the major source thresholds. This rule also finalized amendments to clarify the compliance dates, notification, and recordkeeping requirements that apply to sources choosing to reclassify to area source status and to sources that revert back to major source status, including a requirement for electronic notification.
- The December 4, 2020 amendment updated many of EPA's existing gasoline, diesel, and other fuel quality programs to improve overall compliance assurance and maintain environmental performance. Existing fuel quality regulations were streamlined by removing expired provisions, eliminating redundant compliance provisions (e.g., duplicative registration requirements that are required by every EPA fuels program), removing unnecessary and out-of-date requirements, and replacing them with a single set of provisions and definitions that applies to all gasoline, diesel, and other fuel quality programs. This action did change the stringency of the existing fuel quality standards.
- The August 10, 2022 amendment changed the Code of Federal Regulations (CFR) to reflect a 2015 court decision regarding the NESHAP for Stationary RICE and the NSPS for Stationary Internal Combustion Engines (ICE). The court vacated provisions in the regulations specifying that emergency engines could operate for emergency demand response or during periods where there is a deviation of voltage or frequency. This amendment revises the RICE NESHAP and ICE NSPS to conform to the court's decision.
- The March 29, 2023 amendment promulgated corrections and updates to regulations for source testing of emissions under various rules. This final rule included corrections to typographical and technical errors, updates to outdated procedures, and revisions to add clarity and consistency with other monitoring requirements. The revisions improve the quality of data but do not impose new substantive requirements on source owners or operators.

The amendments to this subpart that are described above do not have any effect on the current permit requirements and will therefore not be addressed further in this evaluation. Therefore, continued compliance is expected.

### H. 40 CFR 82 Subpart B – <u>Servicing of Motor Vehicle Air Conditioners</u>

The purpose of 40 CFR Part 82 Subpart B is to implement section 609 of the Clean Air Act, as amended regarding the servicing of motor vehicle air conditioners (MVACs), and to implement section 608 of the Clean Air Act regarding certain servicing, maintenance, repair and disposal of air conditioners in MVACs and MVAC-like appliances.

These regulations apply to any person performing service on a motor vehicle for consideration when this service involves the refrigerant in the motor vehicle air conditioner.

This subpart was amended on amended July 17, 2019, August 23, 2019, and March 24, 2021. The amendments to this subpart do not have any effect on the current permit requirements and will therefore not be addressed further in this evaluation. The following condition on the draft renewed permit is a mechanism to ensure compliance with the requirements of this subpart:

### I. 40 CFR 82 Subpart F – Recycling and Emissions Reductions

The purpose of 40 CFR Part 82 Subpart F is to reduce emissions of class I and class II refrigerants and their substitutes to the lowest achievable level by maximizing the recapture and recycling of such refrigerants during the service, maintenance, repair, and disposal of appliances and restricting the sale of refrigerants consisting in whole or in part of a class I and class II ODS in accordance with Title VI of the Clean Air Act.

These regulations apply to any person servicing, maintaining, or repairing appliances. This subpart also applies to persons disposing of appliances, including small appliances and motor vehicle air conditioners. In addition, this subpart applies to refrigerant reclaimers, technician certifying programs, appliance owners and operators, manufacturers of appliances, manufacturers of recycling and recovery equipment, approved recycling and recovery equipment testing organizations, persons selling class I or class II refrigerants or offering class I or class II refrigerants for sale, and persons purchasing class I or class II refrigerants.

This subpart was amended on December 27, 2017 and April 10, 2020. The amendments to this subpart do not have any effect on the current permit requirements and will therefore not be addressed further in this evaluation. The

following condition on the draft renewed permit is a mechanism to ensure compliance with the requirements of this subpart:

### IX. PERMIT SHIELD

A permit shield legally protects a facility from enforcement of the shielded regulations when a source is in compliance with the terms and conditions of the Title V permit.
