The Political Reform Act (Government Code Section 81000, et seq.) requires state and 5 6 local government agencies to adopt and promulgate conflict-of-interest codes. The Fair Political 7 Practices Commission has adopted a regulation (2 California Code of Regulations Section 18730) which contains the terms of a standard conflict-of-interest code that can be incorporated 8 by reference in an agency's code. After public notice and hearing, it may be amended by the 9 10 Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of California Code of Regulations, title 2, section 18730, and any 11 12 amendments to it duly adopted by the Fair Political Practices Commission are hereby 13 incorporated by reference. This regulation and the attached Appendices designating positions 14 and establishing disclosure categories shall constitute the conflict of interest code of the San 15 Joaquin Valley Unified Air Pollution Control District (District). 16 Individuals holding designated positions shall file their statements with the **District**, which will make the statements available for public inspection and reproduction. for public inspection in the same manner and location as this conflict-of-interest code (Gov.

8	promulgated and enforced by the District.
9	Category 3 Investments and business positions in business entities, and all sources
10	of income (including loans, gifts, and travel payments) from, entities that filed a claim against the District during the previous two years, or have a
11	claim pending against the District.

13	Category 4 Interests in real property located within the jurisdiction of the District, or
14	within two miles of the boundaries of the jurisdiction of the District, or within two miles of any land owned or used by the District.

16	Category 5 All investments and business positions in, and all sources of income (including gifts, loans, and travel payments) from, business entities that
17	provide services, supplies, materials, machinery, vehicles or equipment
18	of the type purchased or leased by the designated position's Department.
