 - A. C-24-01E CRPC Kettleman Dome

On January 2, 2024, Hearing Board Chair, Daniel Hartwig, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from January 2, 2024, through January 31, 2024. The variance provided relief from specific requirements of District Rules 2070, 2201, 2520 and 4702, and allowed CRPC to continue the production of crude oil and natural gas with two non-compliant engines.
