10. The Central Region Hearing Board heard, and granted, the following emergency variance since the July 19, 2023, hearing:

A. C-23-15E Ardagh Glass Inc.

On August 9, 2023, Hearing Board Chair, Daniel Hartwig, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from August 8, 2023, through September 6, 2023. The variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4101 and CH&SC § 41701, and allowed Ardagh Glass Inc., to continue glass manufacturing with excess visible emissions until the CEMS for SOX at the inlet of the scrubber is certified by completion of a RATA.
