7. **REPORT ON CITIZENS ADVISORY COMMITTEE ACTIVITIES**

Manuel Cunha, Citizens Advisory Committee member, reported on highlights from the meeting held on August 4, 2026.

8. ACCEPT AND APPROPRIATE \$7,465,741 IN ADDITIONAL FUNDING FROM THE CALIFORNIA ENERGY COMMISSION FOR DEPOT CHARGING INFRASTRUCTURE FOR MEDIUM AND HEAVY-DUTY ON-ROAD ZERO-EMISSION VEHICLES

Aaron Tarango, Program Manager, Strategies & Incentives Department, presented the District's \$7.47 million grant award from the California Energy Commission for electric vehicle charging hubs in Stockton and Bakersfield and requested Board approval to accept and appropriate the funding and to enter into the necessary project agreements.

Councilmember Escutia-Braaton asked why the proposed project included only electric charging infrastructure and did not include hydrogen refueling. Mr. Tarango explained that the solicitation allowed for either hydrogen or electric projects, and that the project partners proposed an electric project. Samir Sheikh, Executive Director/APCO, added that project selection is driven by factors such as economics, technology readiness, site considerations, and partner expertise, and noted that the District continues to pursue hydrogen projects where appropriate.

Dr. Sherriffs asked how the project's scale compared to the partner's other renewable energy projects and how prior project experience would support implementation. Mr. Sheikh stated that the project is generally similar in scale to others in the partner's portfolio. Mr. Tarango noted that lessons learned from previous heavy-duty truck electrification projects will inform permitting, utility interconnection, technology selection, and charger requirements.

9. ACCEPT AND APPROPRIATE \$152,214 IN FUNDING FROM THE CALIFORNIA AIR RESOURCES BOARD SUPPLEMENTAL ENVIRONMENTAL PROJECT PROGRAM FOR RESIDENTIAL LAWNMOWER REPLACEMENTS

Todd DeYoung, Director, Strategies & Incentives Department, presented the item requesting Board approval to accept and appropriate \$152,214 in funding from the California Air Resources Board's (CARB) Supplemental Environmental Project Program.

Supervisor Mendes asked how long the funding was expected to last. Mr. DeYoung stated that the District anticipates administering the funding within the fiscal year through the existing residential program, with additional outreach as needed to meet participation goals.

Mayor Pro Tem Lewis asked whether an old lawnmower must be turned in and how the funding would reach communities throughout the Valley. Mr. DeYoung explained that the funding will support the replacement component of the program, which requires an old mower to be turned in and provides greater documented emission reductions. Mr. Sheikh clarified that the funding is available Valley-wide and will be accompanied by targeted outreach to encourage participation in areas with lower program participation.

10. UPDATE ON 2026 WILDFIRE PREVENTION AND RESPONSE EFFORTS

Jon Klassen, Director, Air Quality Science Department, and Heather Heinks,

Program Manager, Outreach & Communications Department, provided an update on the 2026 wildfire season, its impacts on Valley air quality, and the District's efforts to provide residents with resources and outreach to reduce exposure to wildfire smoke.

Councilmember Escutia-Braaton asked whether data was available on the annual number and long-term trend of wildfires in California, including whether community education and outreach efforts may be contributing to changes in fire frequency. Mr. Sheikh responded that approximately 4,600 fires had occurred in 2026 to date, compared with 5,300 at the same point in 2025 and a five-year average of approximately 5,900. He noted that longer-term data could be used to further evaluate the trend.

Dr. Sherriffs commended the District's wildfire resources and its focus on public health and actionable information. He recommended emphasizing that wildfire impacts extend beyond forest fires and highlighted the importance of forest and land management, building hardening, and addressing climate change.

Dr. Pacheco-Werner emphasized the importance of continued investment in wildfire response and suggested developing targeted educational materials for sensitive populations, including pregnant women, older adults, and those with health conditions. Mr. Sheikh supported the suggestion and noted opportunities to further emphasize the health impacts of wildfire smoke and protective measures.

Mayor Pro Tem Lewis asked whether local fire departments and other government agencies are included in wildfire safety education efforts. Ms. Heinks confirmed that local fire departments, community centers, and other agencies are invited and encouraged to participate through the local Fire Safe Councils.

Supervisor Pareira commented on the increased use of early air support to quickly contain wildfires and asked whether this approach was being used Valley-wide. Ms. Heinks confirmed that it was, and Mr. Klassen noted that increased resources and a shift toward rapid fire suppression following severe wildfire seasons have helped reduce the number of acres burned. Supervisor Pareira also recognized CAL FIRE and PG&E for their additional firefighting support.

Chair Shuklian emphasized that wildfire impacts are not limited to forested areas, noting a recent 3,700-acre fire along the Tulare-Kings County line and associated evacuation warnings. She stressed that wildfire impacts are occurring throughout the Valley.

11. REPORT ON STATE BUDGET AND LEGISLATIVE EFFORTS

Mark Montelongo, Director, Policy & Government Affairs Department, provided an

update on the state budget, state and federal legislative activities, and the District's ongoing advocacy efforts to advance Board priorities and secure clean air resources for the Valley.

Mr. Sheikh emphasized the District's year-round efforts to advance the Board's legislative and policy priorities and secure resources for the Valley. He highlighted successes with AB 617 and Clean Cars for All, expressed optimism regarding potential funding for agricultural programs, and thanked the Board, staff, and Valley partners for their continued advocacy.

Vice Mayor Wynn requested that the Board receive an email update on final legislative outcomes once they are available.

Mayor Pro Tem Lewis asked whether other California air districts also participate in funding programs such as Clean Cars for All and FARMER, and whether the funding is Valley-specific or statewide. Mr. Sheikh explained that the funding is statewide, with the Valley receiving a significant share based on program needs and other factors. He noted that the District historically helped develop programs such as Clean Cars for All and FARMER that were later expanded statewide. Mayor Pro Tem Lewis asked about the Valley's historical share of state Clean Cars for All funding. Mr. Sheikh estimated that the Valley typically receives approximately 30-35% of statewide funding and noted that strong local demand and program performance support continued efforts to secure significant allocations.

Mayor Pro Tem Reyna recommended expanding Clean Cars for All outreach to small, rural communities, including Wasco and McFarland, to increase awareness and participation. Mr. Sheikh supported the recommendation and noted opportunities for targeted outreach and community events to ensure residents throughout the Valley are aware of and can access the program.

Dr. Sherriffs commended the District's continued advocacy and asked about AB 2313 and AB 868. Mr. Sheikh noted that the bills raised concerns regarding local control and requirements affecting cities and counties, and emphasized the importance of meaningful input from affected jurisdictions.

12. VERBAL REPORT ON STATE IMPLEMENTATION PLANS

Tim Franquist, Director, Air Quality Planning Department, and Jon Klassen, Director, Air Quality Science Department, provided an update on efforts to attain federal PM_{2.5} and ozone standards, including plan reviews, contingency and

maintenance measures, transportation conformity, and the need for continued state and federal investment in clean air technologies.

Dr. Pacheco-Werner asked how the District is navigating contingency measures and development of the 5% plan amid ongoing litigation, including updates to emissions inventories and modeling and opportunities for public input. Mr. Sheikh explained that the District continues moving forward with approved measures while working with CARB on updated inventories, modeling, and emissions data, with workshops and other opportunities for public input anticipated.

Dr. Pacheco-Werner asked about this year's air quality trends and the influence of wildfire smoke. Mr. Sheikh noted some challenges early in the year but stated that overall ozone conditions have remained relatively favorable, with wildfire smoke contributing to some impacts.

Councilmember Rodriguez commended the District's emissions reductions and suggested incorporating measurable public health benefits into future plans to better demonstrate the impact of the District's efforts.

13. UPDATE ON DISTRICT'S PUBLIC EDUCATION CAMPAIGNS

Jaime Holt, Chief Communications Officer, provided an overview of the District's public education and outreach strategy in support of clean air goals.

Dr. Pacheco-Werner asked about plans to engage high schools and higher education institutions with the District's Annual Report. Mr. Sheikh highlighted efforts to measure engagement with the report and to integrate it into educational outreach. Ms. Holt described enhancements to the program, including plans to promote the digital story map to educators and to explore opportunities to incorporate it into classroom learning.

14. VERBAL REPORT ON CALIFORNIA AIR RESOURCES BOARD ACTIVITIES

Dr. Pacheco-Werner, the Board's representative on the California Air Resources Board, provided a report on recent CARB activities. She highlighted the importance of the upcoming months in identifying additional emissions reduction opportunities and the role of incentives, and encouraged Governing Board participation in upcoming CARB discussions on the carbon capture, removal, utilization, and storage program, noting its potential significance for the San Joaquin Valley.

15. GOVERNING BOARD MEMBER COMMENTS

Mayor Pro Tem Lewis announced an upcoming California Agricultural Leadership Foundation event focused on water availability and the future of agriculture. She encouraged Board members to attend and noted its relevance to Valley farmers.

Supervisor Mendes commended the District's leadership for their efforts on behalf of the Valley and encouraged continued advocacy in Sacramento despite the challenges faced by the District.

16. APCO COMMENTS

Mr. Sheikh provided updates on available funding opportunities, including the newly funded Drive Clean in the San Joaquin rebate program and a federal grant program for municipal and private fleets to purchase Class 6 and 7 electric trucks. He encouraged Board members to share the programs with eligible constituents and businesses. He also reminded the Board that the September Governing Board meeting was moved up one week to September 10, 2026, due to scheduling conflicts.

17. CLOSED SESSION

The Board met in closed session. A written report of any reportable action will be provided to the clerk and made available to the public upon request.
